Weed Control - cutting banana passionfruit along road edge

Pest Control - Possum Poisoning

The above expenditure is estimated

Liability Free NZU Balance at 1 March 2018 - 79,287. Estimated sale of 1500 units @ \$20 in July & 1000 units in November

RDNZ charge out rate is \$98 +GST per hour (this is for non-standard administrative work, i.e. harvest payment processing, international payments, grazing/hive rental negotiations)

International transactions are charged to individual partners @ \$50 per transaction (\$15 bank fee, \$35 RDNZ admin fee)
